Ordinance #27

An Ordinance laying out and opening Locust Road.

Be it enacted and ordained and it is hereby enacted and ordained by the Borough of Deer Lake, Schuylkill County, Pennsylvania as follows:

Section 1.

That for the use, safety, and convenience of the traveling public, the lots or parcels of ground described herein are laid out and opened and known as Locust Road, in the Borough of Deer Lake as follows:

All that certain lot or parcel of ground situate in the Borough of Deer Lake, Schuylkill County, Pennsylvania, bounded and described as follows:

Beginning at an iron pin located on the East right-of-way line of P.D.H. Traffic Route #61, said iron pin being located South twelve (12) degrees and forty-two (42) minutes East (S12° 42' E) a distance of one hundred twenty and sixty-eight hundredths (120.68') feet and South thirteen (13) degrees and fifty-one (51) minutes East (S13° 51' E) a distance of two hundred sixty-five and fifty-nine hundredths (265.59') feet from the point of the intersection of the East right-ofway line of P.D.H. Traffic Route #61 with the South right-of-way line of Oak Road; thence from the place of beginning along other land of the Borough of Deer Lake and along land of Emory Borouch North seventy-two (72) degrees and eighteen (18) minutes East (N72° 18' E) for a distance of one hundred ninetyeight and twenty-six hundredths (198.26') feet to an iron pin on the West right-ofway line of Parkway Drive; thence along said West right-of-way line of Parkway Drive South seventeen (17) degrees and forty-two (42) minutes East (S17° 42' E) for a distance of fifty and no hundredths (50.00') feet to an iron pin; thence along land of the Beiver Realty Company and along other land of the Borough of Deer Lake South seventy-two (72) degrees and eighteen (18) minutes West (S72° 18' W) for a distance of two hundred and eight hundredths (200.08') feet to an iron pin on the East right-of-way line of P.D.H. Traffic Route #61; thence along said East right-of-way line of P.D.H. Traffic Route #61 around a curve having an angle of no (0) degrees, thirty (30) minutes, and twelve (12) seconds (0° 30' 12"), a radius of five thousand six hundred ninety-four and sixty-five hundredths (5,694.65') feet, a tangent of twenty-five and two hundredths (25.02') feet, an arc of fifty and four hundredths (50.04') feet, for a chord course of North fifteen (15) degrees and thirty-three (33) minutes West (N15° 33' W), for a chord distance of fifty and four hundredths (50.04') feet to the place of the beginning.

Being shown in greater detail on a plan laid out by Merlyn J. Jenkins, Registered Surveyor, dated August 13th, 1970 and designated as plan number 5234-A.

Section 2.

That said Locust Road shall be added to and made a part of the street plan of the Borough of Deer Lake.

That this ordinance shall become effective after thirty (30) days.
