#### ZONING PERMIT APPLICATION INSTRUCTIONS

- 1. Application for Zoning permits must be made to the Zoning Officer.
- A Zoning Permit is required for all construction, all remodeling, rewiring, replumbing, and renovating of existing building, auxiliary structures, sidewalks, pools, patios, driveways, fences, etc.
- 3. If the permit is for construction of a new house, an application must be submitted to the Schuylkill County Municipal Authority for a sewer permit. This must be done *prior* to issuance of a building permit. The Authority must install the lateral connection to your property *before* your contactor installs your one from the home to the property line. Contact SCMA at 570-622-8240.
- 4. The zoning permit must be filled out completely, in duplicate, and a sketch to show building size (length, width, height), location on the lot, front, rear and side setbacks. Please ask for zoning ordinance regulations as to this part of the application. Use the attached form for sketch. If help is needed it will be gladly given, copies of zoning ordinance #28 and revisions can be found on the official borough web site. Uniform Construction Code Act #45 building code applies.
- 5. The completed application and sewer permit (where applicable) shall then be submitted to the Zoning Officer along with the required fee (if Check payable to (Borough of Deer Lake) for approval.
- 6. When the application is approved, a zoning permit will be issued along with an authorization card, which must be placed in public view until all construction is completed.
- 7. Should the application be unacceptable, it will be returned to the applicant for correction
- 8. If the permit is denied because of zoning or building code regulations and the applicant feels they have sufficient justification, they may appeal to the zoning hearing board for a review and variance as required by the borough zoning ordinance.
- 9. For construction of new homes, businesses, and any additions to a home or business, detailed plans must include (blueprints, architectural diagrams, a picture diagram of the exterior, and floor plans including all dimensions to scale). these must be submitted with the permit applications.
- 10. Mostly all Zoning Permits also require a Construction UCC Permit, please review <u>ALL</u> permits to see what is necessary for your project/job.
- 11. If you are doing your own work then you must provide a completed Workers' Compensation Affidavit. <u>If you contract out the work then the Contractor must provide a current Certificate of Insurance listing coverage for Workers Compensation.</u>
